The Statutory Auditors of the Company has expressed an unmodified opinion on the Financial Statements.

3 The Board of Directors has recommended a Dividend of ₹ 1.50/- per share (15%) of ₹ 10/- each for approval by the Members of the Company at ensuing Annual General Meeting. In terms of the Ind AS - 10 'Events after reporting date' as notified by the Ministry of Corporate Affairs through amendments to Companies (Accounting Standards) Amendment Rules, 2016, dated 30th March 2016, the Company has not accounted for proposed dividend as liability as at 31th March, 2025.
